Requirements for Social Media Photographer Credentials

- *Must have an established business with Tax ID.*
- *Must provide \$1 Million insurance policy naming NRHA and Oklahoma State Fair as additional insured.*
- *Must fill out application, sign agreement and submit with payment of \$750.*
- *Social media manager photographer credentials will be granted to photographers/media managers of trainers, stallions, businesses, etc. They will not be granted for photographers shooting for non-business enterprises or individuals. For owners wishing to photograph their own horse, please see the section of the social media credential form for owners.*
- *All photographs or videos/reels must be posted to the client's business page (or personal page only if that is the primary one used for business promotion). **In no situation may a photograph or video taken inside the arena be posted to the photographer's personal or business page.***
 - *All photographs posted **must include** the photographer's watermark in a visible location.*
- *Short video clips for reels can be used and posted. No more than 15 seconds of continuous run are allowed. Reels may be posted to both the photographer's business and/or personal pages and the clients' business/personal pages.*

Social media photographers and videographers will be allowed to shoot whichever riders they wish (who are connected to their client) but photos may **only** be posted on **client's** social media page. Once posted there, they can then be **shared** to photographer's personal or public pages, but the original posting must be on client's page. Posted photos must have the photographer's watermark.

Access to Norick Arena:

There will be designated areas for photography for all accredited press representatives and social media representatives. In-arena photos may be taken from these locations only.

There will be no arena access to the Norick Coliseum floor during special presentations for non-media photographers or videographers. Social media photographers can be on the floor during Awards presentations, but are prohibited from taking photos of official win photo setup. Photographers and videographers can not hold up the awards presentations to set up photo opportunities.

Access to Adequan® Arena:

Photos will be allowed from the end area in Adequan® Arena but not in the gate area.

Use of photos:

- Photos taken may be used for graphics (stall front images/enlarged photos/etc.) created for and used by the client.
- Photos may be used for editorial content by publications both online and in print.
- In-Arena Action Photos may **not** be used in print publication advertising.
 - Reaction photos, for example a fist pump after a high score, **can** be used in print advertising.

Guidelines & Application for Owners Photography of Owned horses for Social Media Use 2025 6666 Ranch NRHA Derby presented by Markel

Requirements for Owner Photographer Credentials.

- Must fill out application and sign agreement and submit with payment of \$400.

Owner photographers will be allowed to shoot their owned horses and to post **ONLY** on their social media page.

Access to Norick Arena:

There will be two designated areas for photography for all accredited press representatives and social media representatives. Two sections at each end of Norick Arena will be cordoned off for this purpose. Seats in this area will not be released for ticketing. In-arena photos may be taken from these locations only.

There will be no arena access to the Norick Coliseum floor during special presentations for non-media photographers or videographers. Social media photographers can be on the floor during Awards presentations, but are prohibited from taking photos of official win photo setup. Photographers and videographers can not hold up the awards presentations to set up photo opportunities.

Access to Adequan® Arena:

Photos will be allowed from the end area in Adequan® Arena but not in the gate area.

Use of photos:

- Photos taken may be used for graphics (stall front images/enlarged photos/etc.) created for the client and used by the client.
- Photos may be used for editorial content by publications both online and in print.
In-Arena Action Photos may **not** be used in print publication advertising. *Reaction photos, for example a fist pump after a high score, **can** be used in print advertising.*
- *Short video clips for reels can be used and posted. No more than 15 seconds of continuous run are allowed.*
